UPDATE ON THE REFINANCING OF SENIOR CREDIT FACILITIES THROUGH AMENDMENT AND RESTATEMENT OF SENIOR CREDIT FACILITIES

Samsonite Group S.A. (the “**Company**”) refers to the announcement dated November 2, 2025 (the “**Announcement**”) in relation to (i) the issue by Samsonite Finco of €350.0 million in aggregate principal amount of 4.375% senior notes due 2033 and (ii) the completion of the syndication and allocation of the Company’s New Senior Credit Facilities. Unless otherwise specified, capitalized terms used in this announcement shall have the same meanings as those defined in the Announcement.

The Board is pleased to announce that on November 6, 2025, the closing of the New Senior Credit Facilities occurred.
