As more than 50% of the votes were cast in favour of each of the ordinary resolutions numbered 1 to 9 and not less than 75% of the votes were cast in favour of each of the special resolutions numbered 10 to 12, all resolutions were duly passed.

As at the date of the AGM, the total number of issued shares of the Company was 1,407,710,537 ordinary shares of US\$0.01 each, which was the total number of shares entitling the holders to attend and vote for or against the resolutions at the AGM. There were no shares entitling the holders to attend and abstain from voting in favour at the AGM as set out in rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules").

No shareholder of the Company was required under the Listing Rules to abstain from voting on the resolutions at the AGM. None of the shareholders has stated their intention in the Company's circular dated April 24, 2014 to vote against or to abstain from voting on any of the resolutions at the AGM.

The Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, acted as the scrutineer for the vote-taking at the AGM.

CASH DISTRIBUTION TO SHAREHOLDERS

A cash distribution to the shareholders in the amount of approximately US\$0.0568 per share, representing a total distribution of US\$80,000,000 to be made from the Company's ad hoc distributable reserve was approved in the above ordinary resolution no. 3 at the AGM (the "Distribution"). The payment of the Distribution shall be made in US dollars, except that payment to shareholders whose names appear on the register of members in Hong Kong shall be paid in Hong Kong dollars. The relevant exchange rate shall be the opening buying rate of HK\$ to US\$ as announced by the Hong Kong Association of Banks (www.hkab.org.hk) on the day of the approval of the Distribution, i.e., June 5, 2014 (US\$1 = HK\$7.7225). Accordingly, the amount of cash distribution payable in Hong Kong dollars will be approximately HK\$0.4386 per share.

The payment of the Distribution will not be subject to withholding tax under Luxembourg law.
